a line 362.50 feet south of West Diversey Avenue; the alley next east of North Maplewood Avenue; a line 400.00 feet south of West Diversey Avenue; and North Maplewood Avenue

to those of a B2-INeighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
