**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 6-K in the area bounded by:**

**The public alley next North of and parallel to West 26<sup>th</sup> Street; a line 145.10 feet West of and parallel to South Keeler Avenue; West 26<sup>th</sup> Street; a line 169.10 feet West of and parallel to South Keeler Avenue.**

**To those of a C2-2, Motor Vehicle-Related Commercial District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
