ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City is the owner of the vacant parcel of property located at 4915 South Wabash Avenue, Chicago, Illinois 60615, which is legally described on Exhibit A attached hereto ("Property"), and which Property is located in the 47 /King Drive Redevelopment Project Area ("Area") established pursuant to ordinances adopted by the City Council of the City ("City Council") on March 27, 2002, published in the Journal of Proceedings of the City Council ("Journal") for such date at pages 81232 through 81472; and

WHEREAS, the City, acting through its Department of Housing and Economic Development ("DHED"), has proposed to sell the Property through a sealed bid auction pursuant to Chapter 2-158 of the Municipal Code of the City of Chicago; and

WHEREAS, pursuant to Resolution No. 13-055-21 adopted on August 15, 2013, by the Plan Commission of the City of Chicago (the "Commission"), the Commission approved the sale of the Property; and

WHEREAS, the Commissioner of DHED caused to be published notice advertising the City's intent to sell the Property through a sealed bid auction and such advertisements appeared in the Chicago Sun-Times, a newspaper of general circulation, on June 13, 2013, on June 20, 2013, and on June 27, 2013; and

WHEREAS, the bids received in response to aforesaid the public notice were opened in a public meeting before a certified court reporter and DHED received the following conforming sealed bid: Fannie Lockett in the amount of \$6,400.00; and

WHEREAS, DHED has recommended that the sealed bid of Fannie Lockett, the highest and only bidder be accepted by the City Council; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council hereby accepts the bid of Fannie Lockett, 9632 South Kedvale Avenue, Oak Lawn, Illinois 60453 ("Grantee"), and approves the sale of the Property to the Grantee in the amount of Six Thousand Four Hundred and No/100 Dollars (\$6,400.00).

SECTION 2. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to the Grantee, or to a land trust of which the Grantee is the sole beneficiary, or to a business entity of which the Grantee is the sole controlling party. Such deed shall include a covenant obligating the Grantee to use the Property only for a use consistent with the land uses permitted under the redevelopment plan for the Area. Grantee's acceptance of the quitclaim deed shall constitute Grantee's agreement to such covenant and to comply with such redevelopment obligations.

SECTION 3. DHED is authorized to deliver the quitclaim deed to the Grantee upon receipt of the balance of the purchase price in accordance with its standard procedures. In the event that the closing has not occurred within three months from the passage of this ordinance

through no fault of the City, DHED may cancel the sale upon written notice to the Grantee, retain the Grantee's

earnest money deposit check as liquidated damages, and offer the Property to the next highest bidder.

SECTION 4. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 5. All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed or amended to the extent of such conflict.

SECTION 6. This ordinance shall take effect upon its passage and approval.

If the City determines that any information provided in this EDS is false, incomplete or inaccurate, any contract or other agreement in connection with which it is submitted may be rescinded or be void or voidable, and the City may pursue any remedies under the contract or agreement (if not rescinded or void), at law, or in equity, including terminating the Disclosing Party's participation in the Matter and/or declining to allow the Disclosing Party to participate in other transactions with the City. Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.

D. It is the City's policy to make this document available to the public on its Internet site and/or upon request.
