### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1. That the Chicago Zoning Ordinance be amended by designating with the appropriate symbols and indications that segment of the North Milwaukee Avenue right-of-way on Map No. 7-J in the area bounded by**

the west line of North Kedzie Avenue on the southeast and east line of North Sawyer Avenue where it intersects with the north line of North Milwaukee Avenue on the northwest

**as a Pedestrian Street.**

**SECTION 2. That sections 17-3-503-D and 17-3-0503-E of the Chicago Zoning Ordinance be amended by deleting the language stricken through and inserting the underscored language as follows:**

17-3-0503-D [Pedestrian Streets and Pedestrian Retail Streets.]
