SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No. 11-M in the area bounded by

The alley next north of and parallel to West Irving Park Road; a line 199.44 feet east of and parallel to North Narragansett Avenue; West Irving Park Road; and a line 174.44 feet east of and parallel to North Narragansett Avenue,

to those of a B2-2 Neighborhood Mixed-Use District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
