ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-3 Neighborhood Shopping District symbols and indications as shown on Map No. 11-L in the area bounded by:

A line 250 feet southeast of West Cuyler Avenue (as measured along North Milwaukee Avenue); North Milwaukee Avenue; a line 275 feet southeast of West Cuyler Avenue (as measured along North Milwaukee Avenue); and the alley next West of and parallel to North Milwaukee Avenue.

to those of a CI-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
