SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2017 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Public Health ("Health") has been awarded federal carryover grant funds in the amount of \$33,000 by the Illinois Department of Public Health ("IDPH") which shall be used for the Childhood Lead Poisoning Prevention Program; and

WHEREAS, the City through Health has been awarded additional federal grant funds in the amount of \$566,000 by the United States Department of Health and Human Services which shall be used for the Immunization and Vaccines for Children Program; and

WHEREAS, the City through Health has been awarded private grant funds in the amount of \$25,000 by CVS Health which shall be used for the Opioid Use Prevention and Treatment CVS Program; and

WHEREAS, the City through Health has been awarded federal grant funds in the amount of \$20,000 by IDPH which shall be used for the State Violence & Injury Prevention Program - Dating Matters Program; and

WHEREAS, the City through its Department of Family and Support Services has been awarded federal grant funds in the amount of \$650,000 by the Chicago Cook County Workforce Partnership which shall be used for the Performance Partnership Pilots for Disconnected Youth -Chicago Young Parents Program; and

WHEREAS, the City through its Department of Planning and Development has been awarded state grant funds in the amount of \$3,600,000 by the Illinois Housing Development Authority which shall be used for the Abandoned Residential Property Municipality Program; and

WHEREAS, the City through its Department of Police ("Police") has been awarded federal grant funds in the amount of \$48,000 by the Illinois Criminal Justice Information Authority ("ICJIA") which shall be used for the Violence Against Women - Sexual Assault Program; and

WHEREAS, the City through Police has been awarded federal grant funds in the amount of \$90,000 by ICJIA which shall be used for the Violence Against Women - Domestic Violence Protection Program; and

WHEREAS, the City through its Office of Emergency Management and Communications has

been awarded private grant funds in the amount of \$1,000,000 by the Chicago Cubs Baseball Club, 'LLC which shall be used for the Wrigley Field Cameras Program; and

WHEREAS, the City through its Department of Business Affairs and Consumer Protection has been awarded additional private grant funds in the amount of \$125,000 by Public Education Government which shall be used for the Cable Local Origination Program;

WHEREAS, the City through its Department of Transportation has been awarded federal grant in the amount of \$186,000 by the National Safety Council which shall be used for the Safe System Innovation Grant, now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$6,343,000 not previously appropriated, representing new grant awards, is hereby appropriated from Fund 925 - Grant Funds for the year 2017. The Annual Appropriation Ordinance as amended is hereby further amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. To the extent that any ordinance, resolution, rule, order or provision of the Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
