ODINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-N in an area bound by:

West Addison Street; North Nora Avenue; a line 70 feet south of and parallel to West Addison Street; a line 19.05 feet west of and parallel to North Nora Avenue.

To those of a CI-2 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.
