ORDINANCE ANTWUAN SCOTT Acct. No. 387818-1

Permit No. 1110700

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ANTWUAN SCOTT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Occupation of Space/Fencing on the public right-of-way adjacent to its premises known as 7759 S. Ridgeland Ave..

Said Occupation of Space(s) at East 78th Street (Occupation of Space) measure(s):

One (1) at one hundred twenty-five (125) feet in length, and thirteen (13) feet in width for a total of one thousand six hundred twenty-five (1625) square feet. Property owner shall use land along building lot line to allow access into the property.

Fencing at East 78th Street measure(s):

One (1) at one hundred twenty-five (125) feet in length, and one (1) foot in width for a total of one hundred twenty-five (125) square feet. Existing fencing is approximately six (6) feet in height.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110700 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
