#### ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City has determined that the continuance of a shortage of affordable housing to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City received certain funds from the United States Department of Housing and Urban Development to make loans and grants to expand the long-term supply of affordable housing through, among other things, acquisition, new construction, reconstruction and moderate and substantial rehabilitation in lowand moderate-income areas; and

WHEREAS, the City Council of the City enacted an ordinance on June 8, 2011 which authorized, among other things, (1) the issuance of City of Chicago Multi-Family Housing Revenue Bonds, Series 2011 (Goldblatts Supportive Living Project) in an aggregate amount not to exceed \$18,000,000 (the "Bonds"), (2) a loan of funds in the principal amount of \$1,000,000 (the "Loan") to Goldblatts of Chicago Limited Partnership, an Illinois limited partnership (the "Borrower") the general partner of which was Goldblatts SLF of Chicago GP, Inc., an Illinois corporation (the "General Partner"), and (3) a grant of not to exceed \$2,900,000 in Tax Increment Financing funds (the "TIF Funds") to AHC Ashland LLC, an Illinois limited liability company ("AHC Ashland"); and

WHEREAS, the owners of the General Partner were certain individuals and AHC Ashland; and

WHEREAS, the Bonds were issued, the Loan was made and the TIF Funds were granted on January 30, 2013; and

WHEREAS, the proceeds of the Bonds, the Loan and the TIF Funds (collectively, the "City Financing") are all intended to be used, along with certain other financing sources, to provide for the rehabilitation of a building that formerly contained a Goldblatt's department store into a supportive living residential housing facility containing approximately 101 units (the "Project") by the Borrower on certain real property located generally at 4707 South Marshfield Avenue, Chicago, Illinois 60610 (the "Property"); and

WHEREAS, the Bonds are secured by a first mortgage on the Property; and

WHEREAS, the Loan is evidenced by that certain Note dated as of January 1, 2013 made by the Borrower in favor of the City and secured by, among other things, that certain Junior Mortgage Security Agreement and Financing Statement made by the Borrower in favor of the City recorded as document number 1302922095 in the land title records of the Cook County Recorder of Deeds on January 29, 2013; and

WHEREAS, the provision of the TIF Funds is subject to that certain Redevelopment Agreement dated as of January 1, 2013 by and between the City, the Borrower and AHC Ashland; and

WHEREAS, the Borrower has encountered financial and logistical difficulties in completing the Project due in part to problems discovered by the contractor which lead to an increase in costs; and

WHEREAS, the Borrower intends to obtain additional financing through certain other sources in order to complete the Project; and

WHEREAS, in connection with obtaining such additional financing, the Borrower has requested that the City approve the replacement of the General Partner of the Borrower with CH-GB Affordable Partners, LLC, an Illinois limited liability company (the "New General Partner"); and

WHEREAS, the members of the New General Partner are Celadon Holdings, LLC, an Illinois limited liability company, and AHC Ashland; and

WHEREAS, the Borrower and certain additional parties entered into that certain Withdrawal Agreement dated as of November 20, 2013 pursuant to which the General Partner agreed to voluntarily withdraw from the Borrower and from participation in the Project; and

WHEREAS, the Department of Planning and Development ("DPD") desires to approve a restructuring (the "Restructuring") of the City Financing in a manner which (1) replaces the General Partner of the Borrower with the New General Partner, (2) provides no additional City bond, loan or Tax Increment Financing funds in connection with the Project, and (3) permits the liens on the Property securing the interests of the City in connection with the Bonds, the Loan and the TIF Funds to be subordinated, if necessary, and subject to restrictions in applicable documents, to any new liens required in connection with any new or additional sources of financing determined by the Commissioner of DPD to be necessary or advisable for the completion of the Project in his sole discretion (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner or a designee of the Commissioner (each, an "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with the implementation of the Restructuring. Each Authorized Officer is hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with any future restructuring of the Loan which does not substantially modify the Material Terms. The replacement of the General Partner with the New General Partner is hereby confirmed and approved.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any legal entities which are direct owners in excess of


