ORDINANCE
JOLLY INN RESTAURANT Acct. No.
86620 - 2 Permit No. 1135529

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to JOLLY INN RESTAURANT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 6501 W. Irving Park Rd.. Existing occupation of space is used for a synthetic stucco system applied over existing face brick wall. Existing stucco system measure one hundred (100) feet in length and six (6) inches in width to one (1) inch in width at its widest point and will be twenty-one (21) feet in height Existing stucco system is used as a building beautification over existing masonry walls.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1135529 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
