ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the BI-1 Neighborhood Shopping District symbols and indications as shown on Map No. 15-K in the area bounded by

The alley next northwest of and parallel to North Stevens Avenue; a line 235.18 feet northeast of the intersection of North Stevens Avenue and North Keystone Avenue as measured at the northerly right-of-way line of North Stevens Avenue and perpendicular thereto; North Stevens Avenue; And North Keystone Avenue,

to those of a MI-1 Limited Manufacturing / Business Park District.

SECTION 3. This ordinance shall be in force and effect from and after its passage and due publication.
