**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the BI-1, Neighborhood Shopping District symbols as shown on Map No. 14-J in the area bounded by:**

**The public alley next North of and parallel to West 63<sup>rd</sup> Street; a line 150 feet West of and parallel to South Kedzie Avenue; West 63<sup>rd</sup> Street; a line 200 feet West of and parallel to South Kedzie Avenue.**

**To those of a CI-2, Neighborhood Commercial District**

**SECTION 2. This Ordinance takes effect after its passage and approval.**
