**LOADING ZONES / STANDING ZONES:** 

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

11	S. Halsted Street (west side) from a point 135 feet south of W. James M Rochford Street to a point 20 feet south thereof; no parking standing zone, use flashing lights; 6:00 am to 6:00 pm, Monday through Friday -13-00361523 [02012-8257]
