**SUBSTITUTE ORDINANCE**  
 HILTON HOTELS Acct. No. 88303  
 -1 Permit No. 1106115

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to HILTON HOTELS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, sixteen (16) subsurface (Vaults) under the public right-of-way adjacent to its premises known as 720 S. Michigan Ave.. The dimensions and locations of existing subsurface vaults are as follows:

**Under South Michigan Avenue:**

First (1<sup>st</sup>) level approximately four hundred (400) feet in length and thirty (30) feet in width.

Second (2<sup>nd</sup>) level approximately two hundred fifty-five (255) feet in length and thirty (30) feet in width.

Third (3<sup>rd</sup>) level approximately one hundred fifteen (115) feet in length and fifteen (15) feet in width.

Fourth (4<sup>th</sup>) and fifth (5<sup>th</sup>) levels approximately fifteen (15) feet in length and fifteen (15) feet in width.

Total usage under and along South Michigan Avenue amounts to twenty-one thousand eight hundred twenty-five (21,825) square feet.

**Under East Balbo Street:**

First (1<sup>st</sup>) and second (2<sup>nd</sup>) levels approximately three hundred sixty-nine (369) feet in length and fourteen (14) feet in width.

Third (3<sup>rd</sup>) level approximately one hundred eighty-one (181) feet in length and fourteen (14) feet in width. Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) levels approximately one hundred ten (110) feet in length and fourteen (14) feet in width. Sixth (6<sup>th</sup>) level approximately twenty (20) feet in length and fourteen (14) feet in width.

Total usage under and along East Balbo Street amounts to sixteen thousand two hundred twenty-six (16,226) square feet.

**Under South Wabash Avenue:**

First (1<sup>st</sup>) level approximately three hundred forty-four (344) feet in length and twenty (20) feet in width. Second (2<sup>nd</sup>) level approximately one hundred fifty (150) feet in length and ten (10) feet in width. Third (3<sup>rd</sup>) level approximately twenty (20) feet in length and ten (10) feet in width.

Total usage under and along South Wabash Avenue amounts to nine thousand eight hundred eighty (9,880) square feet.

**Under East B<sup>m</sup> Street:**

First (1<sup>st</sup>) level approximately four hundred twelve (412) feet in length and fourteen (14) feet in width. Second (2<sup>nd</sup>) level approximately one hundred eighty-one (181) feet in length and fourteen (14) feet in width. Total usage under and along East 8<sup>th</sup> Street amounts to eight thousand three hundred two (8,302) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1106115 herein granted the sum of fifty thousand seven hundred thirty-eight (\$50,738.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 02/15/2013.
