 LOADING ZONE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

WARD LOADING ZONES / STANDING ZONES:

- 27 1921 W. Fulton Market (south side) from a point 152 feet west of N. Wolcott Avenue to a point 20 feet west thereof; 15 Minute Standing Zone, use flashing lights, 4:00am to 4:00pm, Monday through Saturday - (13-01665891) [02013-7999]
- 31 4949-4953 W. Diversey Avenue (south side) from a point 100 feet east of N. Lavergne Avenue to a point 30 feet east thereof; No Parking Loading Zone, 4:00am to 7:00pm, Monday through Saturday, tow zone - (13-01552485) [02013-6370]
- 35 3001-3007 W. Diversey Avenue (south side) from a point 85 feet west of N.
