*7?E /r ORDAINED B Y THE CITY COUNCIL OF THE CITY OF CHICA GO:*

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance,  
be amended by changing all the M1-1 Limited Manufacturing/Business Park District  
symbols and indications as shown on Map No. 24-B in the area bounded by

a line 240 feet south of and parallel to East 97<sup>th</sup> Street; a line 193 feet east of and parallel to South  
Torrence Avenue; East 98<sup>th</sup> Street ; and South Torrence Avenue;

to those of a M2-1 Light Industry District is hereby established in the area above described.
