ORDINANCE

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available to persons of low and moderate income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City has certain funds available from a variety of funding sources ("Multi-Family Program Funds") to make loans and grants for the development of multi-family residential housing to increase the number of families served with decent, safe, sanitary and affordable housing and to expand the long-term supply of affordable housing, and such Multi-Family Program Funds are administered by the City's Department of Planning and Development ("DPD"); and

WHEREAS, on or about April 25, 2001, the City made a loan in the Principal amount of \$3,348,189 with an interest rate of One Percent (1%) Per Annum and a term not to exceed 32 years (the "Loan") to Yale Building Limited Partnership, an Illinois limited partnership (the "Original Borrower") with Yale Building Development Corporation, an Illinois corporation ("Yale BDC"), as the sole general partner, funded from Multi-Family Program Funds; and

WHEREAS, the Loan was secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated as of April 25, 2001, made by the Borrower in favor of the City (the "Mortgage"); and

WHEREAS, the proceeds of the Loan were used to provide for the acquisition and rehabilitation of a building located at 6559-6567 South Yale Avenue, a vacant lot located at 6557 South Yale Avenue, and another lot located at 6553 South Yale Avenue, all in Chicago (the "Project"); and

WHEREAS, the Mortgage is subordinate to that certain construction mortgage dated as of April 25, 2001, securing a loan in the amount of \$210,000 (the "Senior Loan"), made by the Original Borrower in favor of Associated Bank, which Senior Loan was sold to Prinsbank in 2007; and ^

WHEREAS, the Original Borrower and Yale Building LLC, an Illinois limited liability company (the "Borrower") desire to (i) allow Borrower to assume the Loan, (ii) refinance the Senior Loan and allow Borrower to execute a mortgage in connection with the Project as described above in favor of a new senior lender (the "New First Mortgage"), and (iii) have the City subordinate the Lien of the Mortgage to the New First Mortgage; and

WHEREAS, DPD desires to approve a restructuring (the "Restructuring") of the Loan in a manner which (1) allows Borrower to assume the Loan, (2) will not alter the principal balance of the Loan, (3) will not alter the interest rate on the Loan, (4) will subordinate the lien of the Mortgage to the lien of the New First Mortgage, and any regulatory agreement entered into by the Original Borrower, and (5) require the Borrower to agree to pay fifty percent of surplus cash calculated annually toward the debt service of the Loan (collectively, the "Material Terms"); now, therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of DPD (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with (i) the implementation of the assumption of the Loan (the "Loan Assumption") and (ii) the subordination of the Mortgage (the "Subordination") to the New First Mortgage. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Loan Assumption and the Subordination which do not substantially modify the Material Terms described herein.

SECTION 3. Notwithstanding anything to the contrary contained in the Municipal Code of Chicago (the "Municipal Code") or any other ordinance or mayoral executive order, no parties other than the owners of the Property as of the date following the date of the closing of the Restructuring (collectively, the "Owner"), any legal entities which are direct owners in excess of 7.5% of the Owner which changed in connection with the Restructuring, and all legal entities who constitute the direct or indirect controlling parties of the Owner (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Restructuring.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
