Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to DSW SHOE WAREHOUSE # 29491, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right -of-way attached to its premises known as 901 W. Weed St..

Said sign structure(s) measures as follows; along FREEMONT ST:

One (1) at eighteen point seven five (18.75) feet in length, five point zero eight <5.08) feet in height and thirty-seven point four two (37.42) feet above grade level.

One (1) at nineteen point three three (19.33) feet in length, one point one seven (1.17) feet in height and ten (10) feet above grade level.

Said sign structure(s) measures as follows; along WEE ST:

One (1) at twelve point three three (12.33) feet in length, four (4) feet in height and forty (40) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.
