SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the MI-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 4-H in the area bounded by:

the public alley north of and parallel to West 17th Street; South Wolcott Avenue; West 17th Street; and a line 26.10 feet west of and parallel to South Wolcott Avenue.

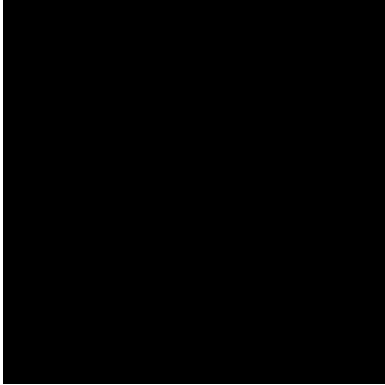
