## LOADING ZONES

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the

following locations are hereby designated as loading zones for the distances specified, during the

hours specified:

#### WARD LOADING ZONES:

- 1 W. Chicago Avenue (south side) from a point 87 feet north of N. Hoyne Avenue to a point 20 feet north thereof: No Parking Loading Zone, 10:00 AM to Midnight, Monday through Saturday/Tow Zone 12-01411280 [02012-5506]
- 2 W Adams Street (north side) from a point 30 feet south of S. Racine Avenue to a point 76 feet south thereof: 15 Minute Standing Zone, must use flashing lights -12-01105042 [02012-3978]
- 15 W. 65th Street (north side) from a point 50 feet west of S. California Avenue to a point 20 feet west thereof: No Parking Disabled Loading Zone at all times (public benefit) - 12-01349014 [02012-4501]
