#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:**

#### WARD                      **LOADING ZONES / STANDING ZONES:**

- 27                      367 West Locust Street (south side) from a point 84 feet east of North Sedgwick Street to a point 20 feet east thereof; No Parking Loading Zone, All Times, All Days -(17-04760275) [02017-5328]
- 27                      855 West Erie Street (south side) from a point 53 feet east of North Green Street to a point 20 feet east thereof; No Parking Loading Zone, 10:00am to 2:00pm, All Days

- 27                      West Locust Street (south side) from a point 20 feet east of North Orleans Street to a point 36 feet east thereof; No Parking Loading Zone, 7:00am to 9:00pm, All Days

- 27                      300 South Halsted Street (west side) from a point 20 feet south of West Jackson Street to a point 20 feet south thereof; No Parking Loading Zone, All Times, All Days, Public Benefit [02018-2522]
- 44                      3469-3475 North Clark Street (east side) from a point 30 feet south of West Cornelia Avenue to a point 35 feet south thereof; 30 Minute Standing Zone, Use Flashing Lights, All

**WARD AMEND LOADING ZONES / STANDING ZONES:**

27 1527 North Wells Street; Amend Ordinance Passed 03/28/2018, which reads: 1527 North Wells Street (east side) from a point 190 feet north of West Burton Place to a point 40 feet north thereof; No Parking Loading Zone, 7:00am to 2:00am, All Days, by Striking: from a point 190 feet north of West Burton Place to a point 40 feet north, and Inserting: from a point 242 feet north of West Burton Place to a point 30 feet north [02018-3155]
