**SALUTE TO THE EXTRAORDINARY BUSINESS AND CIVIC CONTRIBUTIONS OF

WHEREAS, Anne S. Jhin is an outstanding business leader and remarkable citizen of her community who has made extraordinary contributions to the civic weal; and

WHEREAS, Ann S. Jhin now took the lead in expanding the corporate business plan; opening new cash 'n carry outlets in Chicago, Miami, Dallas, Houston, Los Angeles and Mexico City, Mexico as well as a move to a new Chicago location on Cauldwell Avenue, more distribution centers in Chicago, Dallas, Atlanta, Los Angeles, Oakland, the Dominican Republic, Haiti, Trinidad, Mexico and a new international distribution center in New York City; and

WHEREAS, Ann S. Jhin has developed Jinny Beauty Supply into Jinny Corp, the largest multi-cultural beauty and professional salon / barber distributor in the world with a combined warehouse space of 1,280,000 square feet offering 60,000 different items and representing more than 400 manufacturers throughout the nation; and

WHEREAS, Ann S. Jhin's superior business acumen is only matched by her noteworthy community contributions that have been numerous. She is currently President of the National Unification Advisory Council of Chicago, the Chairman of Americas Midwest Korean American Association, an Advisory Commissioner to the Busan Metropolitan government and Chairman of the US-Korea Friendship Network; and
