Your Committee on Transportation and Public Way begs leave to report and recommend that Your Honorable Body pass the proposed ordinance transmitted herewith for a grant of privilege in the public way to BURBERRY LIMITED - 02011-6635 to construct, install, maintain and use two (2) ice melt systems under the public right-of-way adjacent to its premises known as 633 North Michigan Avenue. This ordinance was referred to the Committee on July 28, 2011.

ORDINANCE BURBERRY LIMITED Acct. No. 27266 - 1 Permit No. 1097341

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BURBERRY LIMITED, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use two (2) Ice Melt System(s) under the public right-of-way adjacent to its premises known as 633 N. Michigan Ave..

Said Ice Melt System(s) at N. Michigan measure(s):

One (1) at one hundred twenty point two five (120.25) feet in length, and thirty point five (30.5) feet in width for a total of three thousand six hundred sixty seven point six three (3667.63) square feet.

Said Ice Melt System(s) at E. Ontario measure(s):

One (1) at forty-six point four one (46.41) feet in length, and twenty point zero eight (20.08) feet in width for a total of nine hundred thirty-one point nine one (931.91) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1097341 herein granted the sum of thirty-five thousand three hundred ninety-eight (\$35,398.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from Date of Passage.
