BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 17-H in the area bounded by

A line 143.20 feet north of and parallel to West Estes Avenue; the alley next east of and parallel to North Clark Street; A line 93.20 feet north of and parallel to West Estes Avenue; North Clark Street;

SECTION 2: To those of a C1-2 Neighborhood Commercial District

SECTION 3: This ordinance takes effect after its passage and approval;
