 CHICAGO HILTON & TOWERS Acct. No.
 210667-1 Permit No. 1135536

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to CHICAGO HILTON & TOWERS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, sixteen (16) Vault(s) under the public right-of-way adjacent to its premises known as 720 S. Michigan Ave..

Said Vault(s) at Under S. Michigan Avenue 1st Level measure(s):
 One (1) at four hundred (400) feet in length, and thirty (30) feet in width for a total of twelve thousand (12000) square feet.

Said Vault(s) at Under S. Michiagn Avenue 2nd Level measure(s):
 One (1) at two hundred fifty-five (255) feet in length, and thirty (30) feet in width for a total of seven thousand six hundred fifty (7650) square feet.

Said Vault(s) at Under S. Michigan Avenue 3rd Level measure(s):
 One (1) at one hundred fifteen (115) feet in length, and fifteen (15) feet in width for a total of one thousand seven hundred twenty-five (1725) square feet.

Said Vault(s) at Under S. Michigan Avenue 4th Level measure(s):
 One (1) at fifteen (15) feet in length, and fifteen (15) feet in width for a total of two hundred twenty-five (225) square feet.

Said Vault(s) at Under S. Michigan Avenue 5th Level measure(s):
 One (1) at fifteen (15) feet in length, and fifteen (15) feet in width for a total of two hundred twenty-five (225) square feet.

One (1) at three hundred sixty-nine (369) feet in length, and fourteen (14) feet in width for a total of five thousand one hundred sixty-six (5166) square feet.

Said Vault(s) at Under E. Blabo-Street 3rd Level measure(s):

One (1) at one hundred eighty-one (181) feet in length, and fourteen (14) feet in width for a total of two thousand five hundred thirty-four (2534) square feet.

Said Vault(s) at Under E. Balbo Sttreet 4th Level measure(s):

One (1) at one hundred ten (110) feet in length, and fourteen (14) feet in width for a total of one thousand five hundred forty (1540) square feet.

Said Vault(s) at Under E. Balbo Street 5th Level measure(s):

One (1) at one hundred ten (110) feet in length, and fourteen (14) feet in width for a total of one thousand five hundred forty (1540) square feet.

Said Vault(s) at Under E. Balbo Street 6th Level measure(s):

One (1) at twenty (20) feet in length, and fourteen (14) feet in width for a total of two hundred eighty (280) square feet.

One (1) at three hundred forty-four (344) feet in length, and twenty (20) feet in width for a total of six thousand eight hundred eighty (6880) square feet.

Said Vault(s) at Under S. Wabash Avenue 2nd Level measure(s):

One (1) at one hundred fifty (150) feet in length, and ten (10) feet in width for a total of one thousand five hundred (1500) square feet.

Said Vault(s) at Under S. Wabash Avenue 3rd Level measure(s).

One (1) at twenty (20) feet in length, and ten (10) feet in width for a total of two hundred (200) square feet. Said

Vault(s) at Under E. 8th Street 1st Level measure(s):

One (1) at four hundred twenty (420) feet in length, and fourteen (14) feet in width for a total of five thousand eight hundred eighty (5880) square feet.

Said Vault(s) at Under E. 8th Street 2nd Level measure(s):

One (1) at one hundred eighty-one (181) feet in length, and fourteen (14) feet in width for a total of two thousand five hundred thirty-four (2534) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1135536 herein granted the sum of fifty-seven thousand five hundred eighty-six (\$57,586.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 02/15^018.
