ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 and 3 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022(28.42) and 4-60-022(28.43), as follows:

4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 42) On Cermak Road, from Western to Rockwell Avenue.
- 43) On Cermak Road, from Rockwell Avenue to California Avenue.

SECTION 3. Section 4-60-023.of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023(28.46) and 4-60-023(28.47), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

- 46) On Cermak Road, from Western Avenue to Rockwell Avenue.
- 47) On Cermak Road, from Rockwell Avenue to California Avenue.
