737 NORTH MICHIGAN AVENUE INVESTORS LLC Acct. No.

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 737 NORTH MICHIGAN AVENUE INVESTORS LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Vault (s) under the public right-of-way adjacent to its premises known as 737 N. Michigan Ave..

Said Vault(s) at N. Michigan Avenue 1 Level measure(s):

One (1) at one hundred forty point five (140.5) feet in length, and thirteen (13) feet in width for a total of one thousand eight hundred twenty-six point five (1826.5) square feet.

Said Vault(s) at N. Michigan Avenue 2nd Level measure(s):

One (1) at one hundred forty point five (140.5) feet in length, and thirteen (13) feet in width for a total of one thousand eight hundred twenty-six point five (1826.5) square feet.

Said Vault(s) at E. Superior Street 1st Level measure(s):

One (1) at two hundred forty-one point five (241.5) feet in length, and nineteen point five (19.5) feet in width for a total of four thousand seven hundred nine point two five (4709.25) square feet.

Said Vault(s) at E. Superior Street 2nd Level measure(s):

One (1) at two hundred forty-one point five (241.5) feet in length, and nineteen point five (19.5) feet in width for a total of four thousand seven hundred nine point two five (4709.25) square feet.

Said Vault(s) at N-S Public Alley 1st Level measure(s):

One (1) at sixty-six (66) feet in length, and six point five (6.5) feet in width for a total of four hundred twenty-nine (429) square feet.

Said Vault(s) at N-S Public Alley 2nd Level measure(s):

One (1) at sixty-six (66) feet in length, and six point five (6.5) feet in width for a total of four hundred twenty-nine (429) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1143580 herein granted the sum of thirty-three thousand thirty-five (\$33,035.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
