**West 27<sup>th</sup> Street; a public alley next east of and parallel to South Ridgeway Avenue; a line 50 feet south of and parallel to West 27<sup>th</sup> Street; South Ridgeway Avenue.**

**To those of a B2-2, Neighborhood Mixed-Use District**
