### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM5 Residential Multi-Unit District and BI-1 Neighborhood Shopping District symbols and indications as shown on Map No. 8-E in the area bounded by

A line 231 feet south of and parallel to East 35<sup>th</sup> Street; the public alley next east of and parallel to South Dr. Martin Luther King Jr. Drive; a line 252.80 feet south of and parallel to East 35<sup>th</sup> Street; South Dr. Martin Luther King Jr. Drive,

to those of a BI-2 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
