151 NORTH STATE OWNER LLC Acct. No.: 394278 - 3 Permit

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 151 NORTH STATE OWNER LLC upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, sixteen (16) Caisson(s) under the public right-of-way adjacent to its premises .known as 8 E RANDOLPH ST.

Said Caisson(s) at E. RANDOLPH STREET measure(s):

Five (5) at one (1) feet in length and one (1) feet in width for a total of five (5) square feet. Said Caisson(s) at N. HOLDEN

COURT measure(s):

Seven (7) at one (1) feet in length and one (1) feet in width for a total of seven (7) square feet.

Said Caisson(s) at E.BENNTON PLACE measure(s):

Four (4) at one (1) feet in length and one (1) feet in width for a total of four (4) square feet:

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #BACP 1579618 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


