ORDINANCE

Barbara Holding Company, LLC Acct. No.
418088-1 Permit No. 1129447

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Barbara Holding Company, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use Occupation of Space on the public right-of-way adjacent to its premises known as 3330-3359 S. Ridgeway Ave..

Said Occupation of Space at S. Ridgeway Avenue measure(s):

One (1) at three hundred (300) feet in length, and sixty-six (66) feet in width for a total of nineteen thousand eight hundred (19800) square feet. Existing occupation of space is used to occupy the 3300 block of South Ridgeway Avenue from East 34th Street north for three hundred (300) feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1129447 herein granted the sum of two thousand eight hundred ninety-seven (\$2,897.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
