NOTICE: The licensee shall not be permitted to place any equipment on utility poles unless such equipment is mounted and affixed with a through bolt type attaching device. The through bolt may not be used on poles with a diameter of more than 11.75 inches. The licensee shall coordinate and arrange such with joint owner if licensee elects to have service set up on joint owner facilities. Licensee shall do so upon written request to joint owner (if applicable). Licensee shall not install any equipment on utility poles with static wire. Attachments onto existing fiberglass pole top extensions or onto poles were they present an unusual climbing hazard.

Licensee shall always install its facilities on the same side of the pole as the coated neutral conductor and joint neutral conductor, etc. shall be covered and secured with appropriate guard protector (fiber design by others under separate permit).
