ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Cl-3 Neighborhood Commercial District symbols and indications as shown on Map No.1-G in the area bounded by

the alley next north of and parallel to West Randolph Street; a line 72.21 feet east of and parallel to North Ada Street; West Randolph Street; and North Ada Street,

to those of a Cl-5 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The 1st floor of the proposed seven-story building will contain one commercial unit (1,920 sq. ft.) and a residential (accessory) parking garage (5,959 sq. ft.), with on-site parking for twenty-three (23) vehicles.
