Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 400 W. ONTARIO C/o ADVANTAGE MANAGEMENT, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 400 W. Ontario St..

Said Balcony(s) at W. Ontario measure(s):

Two (2) at fourteen point five (14.5) feet in length, and four point five (4.5) feet in width for a total of one hundred thirty point five (130.5) square feet.

Said Balcony(s) at W. Ontario measure(s):

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1118174 herein granted the sum of four hundred fifty (\$450.00) per annum in advance.
