### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 and 3 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022(16.79) through 4-60-022(16.86), as follows:

#### 4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 79) On 57<sup>th</sup> Street, from Ashland Avenue to Laflin Street.
- 80) On 57<sup>th</sup> Street, from Laflin Street to Loomis Boulevard. (16.81 )On 57<sup>th</sup> Street, from Loomis Boulevard to Throop Street.
- 82) On 57<sup>th</sup> Street, from Throop Street to Racine Avenue.
- 83) On 57<sup>th</sup> Street, from Racine Avenue to Aberdeen Street.
- 84) On 57<sup>th</sup> Street, from Aberdeen Street to Morgan Street.

85) On 57<sup>th</sup> Street, from Morgan Street to Peoria Street.

86) On 57<sup>th</sup> Street, from Peoria Street to Halsted Street.

*(Omitted text is unaffected by this ordinance)*

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023(16.70) through 4-60-023(16.77), as follows:

**4-60-023 Restrictions on additional package goods licenses.**

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

70) On 57<sup>th</sup> Street, from Ashland Avenue to Laflin Street.

71) On 57<sup>th</sup> Street, from Laflin Street to Loomis Boulevard.

(16.72) On 57<sup>th</sup> Street, from Loomis Boulevard to Throop Street.

73) On 57<sup>th</sup> Street, from Throop Street to Racine Avenue.

74) On 57<sup>th</sup> Street, from Racine Avenue to Aberdeen Street.

75) On 57<sup>th</sup> Street, from Aberdeen Street to Morgan Street.

76) On 57<sup>th</sup> Street, from Morgan Street to Peoria Street.

77) On 57<sup>th</sup> Street, from Peoria Street to Halsted Street.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and publication.
