ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 and 3 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022(16.79) through 4-60-022(16.86), as follows:

4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 79) On 57th Street, from Ashland Avenue to Laflin Street.
- 80) <u>On 57th Street, from Laflin Street to Loomis Boulevard. (16.81)On 57th</u>

Street, from Loomis Boulevard to Throop Street.

- 82) <u>On 57th Street, from Throop Street to Racine Avenue.</u>
- 83) <u>On 57th Street, from Racine Avenue to Aberdeen Street.</u>
- 84) <u>On 57th Street, from Aberdeen Street to Morgan Street.</u>

- 85) <u>On 57th Street, from Morgan Street to Peoria Street.</u>
- 86) <u>On 57^{"1} Street, from Peoria Street to Halsted Street.</u>

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023(16.70) through 4-60-023(16.77), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

- 70) On 57th Street, from Ashland Avenue to Laflin Street.
- 71) <u>On 57th Street, from Laflin Street to Loomis Boulevard.</u>

(16.72)On 57th Street, from Loomis Boulevard to Throop Street.

- 73) On 57 Street, from Throop Street to Racine Avenue.
- 74) <u>On 57th Street, from Racine Avenue to Aberdeen Street.</u>
- 75) <u>On 57th Street, from Aberdeen Street to Morgan Street.</u>
- 76) <u>On 57th Street, from Morgan Street to Peoria Street.</u>
- 77) <u>On 57th Street, from Peoria Street to Halsted Street.</u>
