ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City is the owner of the real properties commonly known as 356 and 366 W. Erie Street, Chicago, Illinois, each of which is improved with a surface parking lot, and legally described on Exhibit A attached hereto (subject to final title commitment and survey, the "356 W. Erie Property" and the "366 W. Erie Property", respectively); and

WHEREAS, public notice advertising the City's intent to sell the 356 W. Erie Property appeared in the Chicago Sun-Times, a newspaper of general circulation, on June 13, 22 and 29, 2015, at a listing price of One Million Three Hundred Fifty Thousand and No/100 Dollars (\$1,350,000), which is equal to the 356 W. Erie Property's appraised fair market value; and

WHEREAS, public notice advertising the City's intent to sell the 366 W. Erie Property appeared in the Chicago Sun-Times, a newspaper of general circulation, on June 13, 22 and 29, 2015, at a listing price of One Million Six Hundred Seventy Thousand and No/100 Dollars (\$1,670,000), which is equal to the 366 W. Erie Property's appraised fair market value; and

WHEREAS, the City received multiple responsive bids for the 356 W. Erie Property and for the 366 W. Erie Property; and

WHEREAS, the highest responsive bid for the 356 W. Erie Property was submitted by 356-366 Erie, LLC, an Illinois limited liability company, with a principal business address at 1101 W. Monroe Street, Suite 200, Chicago, Illinois 60607 (the "Grantee"), in the amount of Two Million Two Hundred Thirty Thousand Five Hundred Ninety-Four Dollars (\$2,230,594) (the "356 W. Erie Price"), such amount being greater than the aforementioned appraised fair market value of the 356 W. Erie Property; and

WHEREAS, the highest responsive bid for the 366 W. Erie Property was submitted by the Grantee, in the amount of Two Million Six Hundred Fifty-Four Thousand Four Hundred Six Dollars (\$2,654,406) (the "366 W. Erie Price"), such amount being greater than the aforementioned appraised fair market value of the 366 W. Erie Property; and

WHEREAS, the City, acting by and through its Department of Planning and Development (the "Department"), desires to sell the 356 W. Erie Property to the Grantee for the 356 W. Erie Price; and

WHEREAS, the City, acting by and through the Department, desires to sell the 366 W. Erie Property to the Grantee for the 366 W. Erie Price; and

WHEREAS, pursuant to Resolution No. 15-081-21 adopted on September 17, 2015, by the Plan Commission of the City (the "Commission"), the Commission recommended that the City, acting by and through the Department, enter into a negotiated sale with the Grantee for the purchase of the 366 W. Erie Property; and

WHEREAS, pursuant to Resolution No. 15-082-21 adopted on September 17, 2015, by the Commission, the Commission recommended that the City, acting by and through the Department, enter into a negotiated sale with the Grantee for the purchase of the 356 W. Erie Property; and

WHEREAS, the 356 W. Erie Property and the 366 W. Erie Property were marketed by the City's real estate broker, CBRE, Inc., pursuant to the terms of its master consulting agreement with the City, with the transaction subject to a three and three-quarters percent (3.75%) brokerage commission fee, which fee will be paid to CBRE, Inc., by the City; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The City Council of the City hereby approves the sale of the 356 W. Erie Property and the 366 W. Erie Property to the Grantee for the 356 W. Erie Price and the 366 W. Erie Price, respectively. This approval is expressly conditioned upon the Department's entering into a purchase agreement with Grantee (the "Purchase Agreement"). The Commissioner of the Department ("Commissioner") or a designee of the Commissioner is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver the Purchase Agreement, which Purchase Agreement shall include such customary terms as the Commissioner deems reasonable (including City indemnification of the Grantee relating to third-party claims for real estate or brokerage commissions or finder's fees) and such other supporting documents as may be necessary or appropriate to carry out and comply with the provisions of the Purchase Agreement.

SECTION 3. The Commissioner of the City's Department of Fleet and Facility Management or a designee of such commissioner is each hereby authorized, with the approval of the City's Corporation Counsel as to form and legality, to negotiate, execute and deliver a right of entry for the benefit of the Grantee, with respect to survey work, environmental testing and geotechnical work to be performed at the 356 W. Erie Property and the 366 W. Erie Property.

SECTION 4. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Property to Grantee.

SECTION 5. The transfer of title to the 356 W. Erie Property and the 366 W. Erie Property to the Grantee must close on or before the date that is one hundred twenty (120) days following the publication of this

ordinance (the "Outside Closing Date"), unless the Department, in its sole discretion extends such Outside Closing Date. If the closings do not occur by the Outside Closing

Date, this ordinance shall be null and void and the Grantee shall forfeit the Two Hundred Twenty-Three Thousand Fifty-Nine and 40/100 Dollars (\$223,059.40) good faith purchase deposit tendered concurrently with the Grantee's bid for the 356 W. Erie Property, and the Two Hundred Sixty-Five Thousand Four Hundred Forty and 60/100 Dollars (\$265,440.60) good faith purchase deposit tendered concurrently with Grantee's bid for the 366 W. Erie Property.

SECTION 6. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 7. All ordinances, resolutions, motions or orders in conflict with this ordinance are hereby repealed to the extent of such conflict.

SECTION 8. This ordinance shall take effect immediately upon its passage and approval.
