BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Business District symbols and indications as shown on Map No. 22-H in the area bounded by

A line 378 feet south of and parallel to West 91<sup>st</sup> Street; a line 122 feet east of and parallel to South Western Avenue; a line 453 feet south of and parallel to West 91<sup>st</sup> Street; South Western Avenue,

to those of a C2-2 Motor Vehicle Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
