## ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City is the owner of the vacant parcels of property located at 4300 West Carroll Avenue and the East 17 Feet of 4302 West Carroll Avenue and 4306-14 West Carroll Avenue Chicago, Illinois 60624, which are legally described on Exhibit A attached hereto (the "Properties"), which Properties are located in the Northwest Industrial Corridor Redevelopment Project Area ("Area"), as amended, established pursuant to ordinances adopted by City Council of the City ("City Council") on December 2, 1998, published in the Journal of Proceedings of the City Council for such date at pages 86178 through 86395.

WHEREAS, Frank Czarkowski, with a principal business address of 4300-14 West Kinzie Street, Illinois 60624, has offered to purchase the Properties from the City for the sum of Forty-three Thousand and 00/100 Dollars (\$43,000.00), such amount being the appraised market value of the properties; and

WHEREAS, public notice advertising the City's intent to enter into a negotiated sale of the Properties with Frank Czarkowski and requesting alternative proposals appeared in the Chicago Sun-Times, a newspaper of general circulation, on December 15, 2017, and December 22, 2017; and

WHEREAS, the Department of Planning and Development (the "Department") received an alternative proposal in response to the public notice from Sean Kelly with a principal business address of 4425 West Kinzie Street, Chicago, Illinois 60624 ("the grantee"), which offered to purchase the Property for Fifty Thousand and No/100 Dollars (\$50,000.00) in order to use the Properties as an industrial open space; and

WHEREAS, The Department has evaluated both proposals and has found the proposal submitted by the Grantee to be in the best interest of the City; and

WHEREAS, pursuant to Resolution No. 18-036-21 adopted on June 21, 2018, by the Plan Commission of the City (the "Commission"), the Commission approved the negotiated sale of the Property to the Grantee; now, therefore,

### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. The City Council hereby approves the sale of the Properties to the Grantee for the amount of Fifty Thousand and 00/100 Dollars (\$50,000.00).

SECTION 2. The Mayor or his proxy is authorized to execute, and the City Clerk or Deputy City Clerk is authorized to attest, a quitclaim deed conveying the Properties to the Grantee. Such deed shall include a covenant obligating the Grantee to use the Properties only for use consistent with the land uses permitted under the redevelopment plan for the Area. Grantee's acceptance of the City's deed shall constitute Grantee's agreement to such covenant. The quitclaim deed shall also contain language substantially in the following form:

This conveyance is subject to the express condition that: the Properties are improved as an industrial open space within six (6) months of the date of this deed. In the event that the condition is not met, the City of Chicago may re-enter the Properties and re-vest title in the City of Chicago. Grantee, at the request of the City of Chicago, covenants to execute and deliver to the City a reconveyance deed to the Properties to further evidence such re-vesting of title. This right of reverter and re-entry shall terminate upon the issuance of a certificate of completion, release or similar instrument by the City of Chicago.

The Grantee acknowledges that if the Grantee develops the Properties with a residential housing project, as defined under and that is subject to Section 2-45-115 of the Municipal Code of the City (the "2015 Affordable Requirements Ordinance"), the Grantee and such project shall be obligated to comply with the 2015 Affordable Requirements Ordinance.

SECTION 3. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 4. All ordinances, resolutions, motions or orders inconsistent with this ordinance are hereby repealed to the extent of such conflict.

SECTION 5. This ordinance shall take effect upon its passage and approval.
