BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-H in area bound by

A line 212 feet East and parallel to North Hoyne Avenue, West St. Paul Street, a line 236.04 feet East and parallel to North Hoyne Avenue, the alley next South and parallel to West St. Paul Street.
