#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1.1-H in the area described as follows:

Commencing at a point on the center line of North Hermitage Avenue, 88.12 feet south of the south line of West Belle Plaine Avenue; thence west and parallel to the south line of West Belle Plaine Avenue a distance of 135 feet; thence north a distance of 20.00 feet; thence west a distance of 57.00 feet; thence northwest a distance of 17.04 feet to a point 205.00 feet west of the center line of North Hermitage Avenue and 57.12 feet south of the south line of West Belle Plaine Avenue; thence south a distance of 161.54 feet; thence east a distance of 205.00 feet thence north along the center line of North Hermitage Avenue, a distance of 130.54 feet to the point of beginning

to those of a B2-5 Neighborhood Mixed Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

# Narrative Type I Rezoning Attachment

#### **The Project**

Hermitage Partners LLC (the "Applicant") is proposing an adaptive reuse of an existing 3 story brick building, originally built as a screw and bolt factory, then most recently used as a dwelling unit together with a law office and warehouse space. The Applicant proposes to build office space on the first and second floors, to build corporate dwelling units on the first floor, and to build a residential unit on the third floor.

#### The Site

The site is located on the west side of Hermitage Avenue. The land use in the immediate area of the proposed rezoning is residential, industrial and office. To the south is a single family house; to the north is a two and a half story residential building; to the east across the street are residential buildings; and to the west across the alley are industrial and office uses. The Applicant's proposed mixed use development is to include residential and office uses and is an appropriate land use at this location.

The following are the relevant bulk calculations for the proposed development:

floor area ratio: 1.9;

lot area per dwelling unit: 7,670 square feet per dwelling unit;

off-street parking: 15 parking spaces;

setbacks: front = 19 feet, 8 inches rear = 0 side/north = 0
