BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single- Unit (Detached House) District symbols and indications as shown on Map No. 3-1 in area bound by

North California Avenue, a line 50 feet South of and parallel to West Potomac Avenue, a line 135 feet East and parallel to North California Avenue, a line 75 feet South of and parallel to West Potomac Avenue,

to those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and approval.

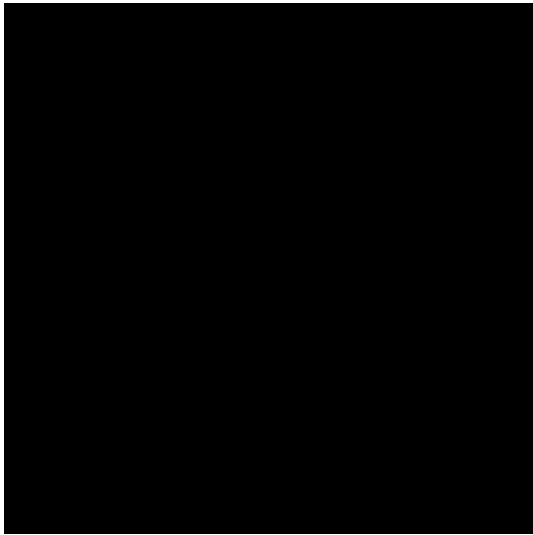
