ORDINANCE

BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 1-J in the area bounded by:

A line 200 feet north of and parallel to west Maypole Avenue; the alley next east of and parallel to North Pulaski Road; a line 100 feet north of and parallel to west Maypole Avenue; and North Pulaski Road.

To those of a C2-2 Motor Vehicle-related District.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.
