#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Section 2-92-420 of the Municipal Code of Chicago is hereby amended by deleting the struck-through language as follows:

For calendar-year 2001 and beyondi this sum-shatr-be adjusted upwards-or downwards by applying to it a rate equal to the Consumer Price Index for Urban Wa§e Earners and Clerical Workers (CPI W) published by the United States-Bureau-of Labor Statistics for that calendar year.
