ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Section 17-12-1002-F of Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by deleting the struck-through language and inserting the underscored language as follows:

17-12-1002-F Table of Allowed Sign Types. Signs are allowed in B, C, M, DC, DX and DS zoning districts as follows:

SECTION 2. Section 17-12-1005-E of Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by deleting the struck-through language and inserting the underscored language as follows:

17-12-1005-E <u>Marquee Signs. Marquee signs must be</u> <u>affixed flat to the</u> <u>surface</u> <u>of the</u> <u>marquee and not e</u> <u>xtend horizontally or vertically beyond the</u> <u>limits of the</u> <u>marquee.</u> Reserved.

SECTION 3. This ordinance shall be in force and effect from and after its passage and publication.
