BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

A line 29.14 feet north of and parallel to East 77th Street; South Langley Avenue; East 77th Street; the alley next west of and parallel to South Langley Avenue.

To those of a RM - 4.5 Residential Multi-Unit District.
