(1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 7428 W. Belmont Ave..

Said. Awning(s) at VV, Belmont Avenue measure(s): ! One (1) at twenty-four point six seven. (24.67) feet in length, and two pointthree three (2.33) feetiin width for a total of-fifty-seven point four eight (57.48) square feet.

The location of said privilege shall be as shown on prints kept on file with-the Department of Business Affairs and Consumer Protection and the Office of the City Clerk. I

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department-Signs.
