BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

A line 173.5 feet east of and parallel to North Southport Avenue, the public alley next north and parallel to West Belmont Avenue, a line 221.5 feet east of and parallel to North Southport Avenue, West Belmont Avenue

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
