BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indications as shown on Map No. 8-G in an area bound by:

West 32<sup>nd</sup> Place; South Carpenter Street; a line 24.0 feet South of and parallel to West 32<sup>nd</sup> Place; and the alley next West of and parallel to South Carpenter Street.

To those of a RM-4.5 Residential Multi-Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.


